initiatives to reach Mutual Recognition Agreements
(MRAs) with other customs administration.



For this purpose as a previous step to the signature of MRAs it began developing important agreements as Safety Supply Chains with strategic partners.

BRAZIL Pilot Agreement on Safety Supply Chain with Uruguay

By this agreement both countries continue to advance with planification, so as to start the pilot program in the 2015 second semester.

ARGENTINA "Bilateral Agreement for the implementation of Pilot Program Intra-Mercosur Customs Security in the Supply Chain"

After a survey in border points conducted by both customs administrations selected companies for commercial national chains participate in this pilot program it is subsequent bilateral implementation.

PANAMA Memorandum of Understanding between the National Customs of Uruguay and the National Customs Authority of Panama.

The signing of an understanding Memorandum between both administrations is has been agreed.

Is planned to be performed during the XVIII Regional Conference of Customs of the Americas and the Caribbean in Puerto Natales, Chile, scheduled for April 2015. The objective for the signing of this Memorandum is based on technical assistance for AEO programs in both countries through the exchange of best practices acquired in order to lay the foundation for harmonizing customs regimes in search of promoting mutual recognition.

MEXICO Memorandum of Understanding between the National Customs of Uruguay and the General Administration of Customs of United States of MEXICO on institutional cooperation and technical assistance.

Both customs are developing a Memorandum of Understanding to start harmonizing both programs.

Currently this memorandum is under consideration by the US Customs of Mexico, Uruguay has already delivered a draft.

A work plan which will include exchange of technical assistance between the two organizations will be developed.

NEW CERTIFIED COMPANIES

In December 2014 new certificates were given to two companies who have met the highest safety standards in customs operations, complying with the requirements of the AEO Program.
