# **NEW BENEFITS FOR AEO CUSTOMS BROKERS**

#### USE OF PAPER DOCUMENTS



In those cases of imports operation for which red or orange revision channel has been assigned, in which paper documents have to be presented, the AEO certified customs broker will be able to request the use of the DAE\* associated to the DUA\*\*, the PDF format substitute of the DUA form available in the LUCIA system, and the hard copies the Customs Broker might provide.

This benefit does not exempt customs brokers from the obligation of keeping the original paper documents and storing them. This documents might be exceptionally requested in the case the customs officer who is responsible for that operation, demands them with a valid reason.

#### MODIFICATIONS TO THE RED CHANNEL EXPORTS DUA\*\* IN THE THIRD MESSAGE

The AEO customs broker, will be able to modify in the third message, -in the export operations for which red channel was assigned-, the same fields that are enabled to be changed in the green channel operations.

\*DAE: Electronic Customs Document

\*\*DUA: Single Customs Document
